Woodrow & Loyal Hoffman Scholarships

- \$5,000 Post-Secondary Scholarship awarded to two students (1 male and 1 female)
- Student must have cumulative GPA of at least 2.0 on a 4.0 scale
- Hueftle and Hoffman applicants must enroll full-time in college or technical school for the Fall 2019 term. Hoffman applicants must attend a school within the State of Kansas.
- Hoffman scholarships only-brief interview with Foundation Trustees. **Finalists will be notified by Mrs. Price and must be available for interview.**

Scott Community Foundation Scholarship

- \$2,500 total (\$1,500 from SCF & \$1,000 from Hueftle)
- Post-Secondary Scholarship awarded to two students
- 1 male and 1 female; Hoffman interviewees

Everett Hueftle Scholarships

- \$1,000 Post-Secondary Scholarship awarded to two students (1 male and 1 female)
- \$1,000 Post-Secondary Scholarship awarded to six students
- Student must have a cumulative GPA of at least 2.0 on a 4.0 scale

Glenn Novak Scholarships

- \$1,000 Post-Secondary Scholarship will be awarded to two students
- Student must be attending a College or University with the intent of obtaining a degree in an Agricultural or Animal Sciences related field.
- Student must have a cumulative GPA of at least 2.5 on a 4.0 scale

Albert & Dee Hoeme Memorial Scholarship

- \$1,000 Post-Secondary Scholarship awarded to one student
- Student must have a cumulative GPA of at least 2.0 on a 4.0 scale

Labache Ag. Inc. Scholarship

- \$5,000 Post-Secondary Scholarship awarded to two students for two years (\$2,500 each year)
- Student who has the capabilities of getting a college degree but because of financial burden cannot go to college or may not even think or consider getting a college degree.
- Lack of family support to get a degree
- Priority given to second generation of immigrants that may or may not be legal in the US.

- Student must have a 3.0 GPA
- Student must have been a student athlete at SCHS

- Student must be obtaining a degree from a college or university in an agricultural or animal sciences related field

- \$1,000 Post-Secondary Scholarship awarded to one student
- Based on need

Raymond & Hildred Armantrout Scholarship

- \$4,000 Post-Secondary Scholarship awarded to two students for two years (\$2,000 each year)
- Student must be in top 1/3 of class
- Student must be pursuing bachelor's degree in any field

Larry Vulgamore Memorial Scholarship

- \$1,500 Post-Secondary, 4 year Scholarship
- Student must be pursuing degree in an agricultural related field
- Applicant must be a child of current employee of Vulgamore Family Farms
- Renewable Subject to funding

Ruby Wilkens Music Scholarship

- \$1,000 Post-Secondary Scholarship awarded to one student
- Student must be pursuing degree in a music related field

William Dryer Memorial Scholarship

- \$500 Post-Secondary Scholarship awarded to one student
- Student must have a cumulative GPA of at least 2.5 on a 4.0 scale


