The Board of Education of Unified School District No. 466 met in regular session on Monday, June 12, 2023, at 7:00 p.m. in the Administration Building Board Room, 704 S. College, Scott City, KS, with the following members present:

President Scott Noll called the meeting to order at 7:00 p.m. with the Pledge of Allegiance.

Motion to Adopt the Agenda

Board Representative Reports

Julia Cheney did not have new information as the meeting is later in the month for Northwest Tech.

Administrative Reports

Dr. Shawn Roberts, Scott City Elementary School Principal, shared the SCORE program will have a summer session in June.

- USD 466 website will be updated over the summer with the group of Superintendent Rumford, David Dirks, Technology Director, and the principals.
- Safe School Grant has been applied for and will know results by June 19th after the KS State Board of Education meeting.

Treasurer's Report, Bills Payable and Bond Financials

The Board requested to view the financial reports in portrait mode or provide a printed copy for future meetings as it is difficult to view in landscape mode within the board packet.

There is anticipation of the school district receiving a dividend due to participation in EMC Insurance Safety Group Program for Kansas Schools. The board inquired further about the cannabis exclusion, cyber security incident exclusion, exclusion of loss due to virus and Mr. Green agreed to provide additional information later in the week. The Shallow Water school is covered only on the contents of the

building but not the building itself. Mr. Green confirmed that the turf is covered under the blanket policy based on replacement costs of agreed value.
